





Figure B.2: Adjusted Quarterly Trends for 30-Day All-Cause Mortality for Full, Active, and Exiting Cohorts*




Figure B.4: Adjusted Quarterly Trends for 30-Day All-Cause Mortality for PHC, Expansive, and Targeted Cohorts*












Figure B.10: Adjusted Quarterly Trends for 30-Day Pneumonia-Related Mortality for Full, Active, and Exiting Cohorts*








Figure B.14: Adjusted Quarterly Trends for 30-Day Heart Failure-Related Mortality for Full, Active, and Exiting Cohorts*








Figure B.18: Adjusted Quarterly Trends for 30-Day All-Cause Readmissions for Full, Active, and Exiting Cohorts*




Figure B.20: Adjusted Quarterly Trends for 30-Day All-Cause Readmissions for PHC, Expansive, and Targeted Cohorts*












Figure B.26: Adjusted Quarterly Trends for 30-Day Pneumonia-Related Readmission for Full, Active, and Exiting Cohorts*








Figure B.30: Adjusted Quarterly Trends for 30-Day Heart Failure-Related Readmission for Full, Active, and Exiting Cohorts*








Figure B.34: Unadjusted Quarterly Trends for ICU Use By Awardee Hospital for Active and Exiting Cohorts*











Figure B.39: Adjusted Quarterly Trends for Episode Length of Stay for Full, Active, and Exiting Cohorts*




Figure B.41: Adjusted Quarterly Trends for Episode Length of Stay for PHC, Expansive, and Targeted Cohorts*




Figure B.43: Adjusted Quarterly Trends for Total Medicare Episode Payment for Full, Active, and Exiting Cohorts*




Figure B.45: Adjusted Quarterly Trends for Total Medicare Episode Payment for PHC, Expansive, and Targeted Cohorts*




Figure B.47: Adjusted Quarterly Trends for Medicare Episode Payment – Hospital Only for Full, Active, and Exiting Cohorts*




Figure B.49: Adjusted Quarterly Trends for Medicare Episode Payment – Hospital Only for PHC, Expansive, and Targeted Cohorts*




Figure B.51: Adjusted Quarterly Trends for Medicare Episode Payment – Non-Hospital Only for Full, Active, and Exiting Cohorts*








Figure B.55: Adjusted Quarterly Trends for 30-Day Post-Episode Medicare Payments for Full, Active, and Exiting Cohorts*




